DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Briana Hunt Simmons, in Georgetown County, during the periods of 11/13/19 through 05/31/24, did knowingly and willfully by means of false statement and representation fraudulently obtain Supplemental Nutrition Assistance Program benefits, based on her submission of 8 SNAP Application Forms, dated 11/13/19, 10/29/20, 05/05/21, 10/13/21, 04/15/22, 10/14/22, 10/05/23, 04/12/24. On these application forms, the defendant stated she lived at 1241 Tyler Dr., Hemingway SC, 29554, and listed only herself and her six minor children as household members. The defendant willfully excluded her cohabitating husband, Carlton Simmons, and his income from these applications. As a result, the defendant received an overpayment of \$56,762.00 in SNAP benefits throughout the claim period which she was not entitled to receive. The facts to establish probable cause are based upon property records, SCDMV records, marriage certificate, statements from witnesses, and OIG Investigation (Case No. 257069).
