Personally appeared before me the affiant Special Agent Patrick W. Young of the South Carolina Department of Social Services, Office of Inspector General, who being duly sworn, deposes and says that the defendant, Cory Nicole Baker (W/F; DOB: [REDACTED] SCDL: [REDACTED]), did within the County Charleston and State of South Carolina from October 1, 2017 to July 31, 2022 violate the criminal laws of the State of South Carolina in the following particulars:


Fraudulent Acquisition or Use of Food Stamps (Greater than \$10,000)
16-13-430 (A)(1)(C)(1)

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:

That the defendant, Cory Nicole Baker, in Charleston County, during the period of ~~OCTOBER 1, 2017 TO JULY 31,~~^{PME} 2022, did knowingly and willfully by means of false statement and representation fraudulently receive Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of ten (10) annual certification and/or semiannual recertification forms, dated September 15, 2017, February 26, 2018, August 30, 2018, March 21, 2019, September 16, 2019, March 2, 2020, September 3, 2020, March 1, 2021, September 13, 2021, and March 3, 2022, where the defendant willingly and knowingly reported to DSS four minor children in her household composition, who were not in her custody during the aforementioned benefit period. As a result, the defendant received an overpayment of \$36,201.00 in SNAP benefits in which she was not entitled to receive.

Facts to establish the above charge against the defendant, Cory Nicole Baker, are based on records, and the statement of witnesses. Based on the above there is probable cause to believe that the defendant violated South Carolina Code of Laws Section 16-13-430 (A)(1)(C)(1).
