DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Jennifer Geddings, in Sumter County, during the claim period of 10/13/2022 through 10/31/2024, did knowingly and willfully by means of false statement and representation fraudulently obtain Supplemental Nutrition Assistance Program (SNAP) benefits, based on her submission of three (3) SNAP Application Forms, dated 10/13/2022, 10/16/2023, and 05/01/2024. On each of the application forms the defendant listed only herself and her three children as household members. The defendant willfully excluded her husband, [redacted] and his income from each application. [redacted] provided a verbal statement that they are married and living with the defendant. The defendant's neighbors also stated that the couple lives together. As a result the defendant received an overpayment of \$21,716.00 in SNAP benefits during the claim period which she was not entitled to receive. The facts to establish probable cause are based upon records obtained, statements from witnesses, and OIG investigation
