I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Marcia Marie Kidd aka Monica Kidd Coleman, in Beaufort County, during the period of February 1, 2019 to December 31, 2021, did knowingly and willfully by means of false statement and representation fraudulently receive Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of six (6) annual certification and/or semiannual recertification forms, dated January 25, 2019, July 17, 2019, January 13, 2020, July 22, 2020, January 14, 2021, and July 16, 2021, where the defendant willingly and knowingly, failed to report her husband, Andre Coleman, and his income from employment with Community Services Association, on the aforementioned forms during the benefit period. As a result, the defendant received an over issuance of \$12,571.00 in SNAP benefits for which she was not entitled to receive.
