Personally appeared before me the affiant Alexander R Nguyen who being duly sworn deposes and says that defendant Sasha Michelle Price did within this county and state on or about 12/ 1/2021 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of Dillon) in the following particulars:

DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Sasha Price, in Dillon County, during the periods of December 1, 2021, through November 31, 2022, did knowingly and willfully by means of false statement and representation fraudulently obtain Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of three (3) SNAP Application Forms dated: December 28, 2021, May 2, 2022, and November 2, 2022. On all three SNAP Application Forms the defendant falsely reported her biological son, [] as a household member when he was not in her legal or physical custody. As a result, the defendant received an overpayment of \$10,217.00 in SNAP benefits which she was not entitled to receive. The Affiant's belief is based upon records, witness statements, and OIG Investigation 193949.
