did within this county and state on or about 4/26/2019 violate the criminal laws of the

State of South Carolina (or ordinance of County/ Municipality of Greenwood)

in the following particulars:

DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Erin Elizabeth Barber, in Greenwood County, during the periods of April 26, 2019 through March 31, 2020 and October 1, 2020 through September 30, 2023, did knowingly and willfully by means of false statement and representation fraudulently obtained Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of eight (8) SNAP Application Forms dated April 26, 2019, September 30, 2019, October 14, 2020, March 2, 2021, September 8, 2021, April 8, 2022, October 3, 2022, and March 7, 2023. On six (6) of the SNAP Application Forms, the defendant reported herself and her two (2) biological children in her SNAP household composition. Investigation revealed that during the benefit periods, the children were attending school and living with their biological father in Rock Hill, SC. As a result, the defendant received an overissuance of \$21,445.00 in snap benefits for which she was not entitled to receive. R/O J. M. Days OIG Inv. 172301
