Personally appeared before me the affiant Patrick W Young, III who being duly sworn deposes and says that defendant Hayley Erin Hayes did within this county and state on or about 2/1/2019 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Orangeburg) in the following particulars:

DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts.

That the defendant, Hayley Erin Hayes, in Orangeburg County, during the period of February 1, 2019 to July 31, 2022, did knowingly and willfully by means of false statement and representation fraudulently receive Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of seven (7) annual certification and/or semiannual recertification forms, dated February 6, 2019, August 13, 2019, January 16, 2020, August 3, 2020, February 1, 2021, August 4, 2021, and February 7, 2022, where the defendant willingly and knowingly reported to DSS two (2) minor children in her household composition, who were not in her custody during the aforementioned benefit period. As a result, the defendant received an over issuance of \$14,474.00 in SNAP benefits in which she was not entitled to receive.
