AFFIDAVIT

Personally appeared before me the affiant Anna Caroline Kinney being duly sworn deposes and says that defendant Malaya Teaira Johnson did within this county and state on or about 8/23/2019 violate the criminal laws of State of South Carolina (or ordinance of  County/  Municipality of Fairfield) in the following particulars:

DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Malaya Brasley, Malaya Fee, Malaya Teaira Johnson, Malaya Brasley Fee, in Fairfield County, during the periods of August 23, 2019, to January 31, 2020 and June 23, 2020, to May 31, 2022, did knowingly and willfully by means of false statement and representation fraudulently receive Supplemental Nutrition Assistance Program (SNAP) benefits. Specifically, the defendant submitted six (6) SNAP Application Forms dated: August 23, 2019, January 24, 2020, June 23, 2020, November 19, 2020, May 13, 2021, and November 22, 2021, where the defendant knowingly and willfully, failed to report as required, her husband, Justin Fee, as a household member along with his employment and income from the Town of Winnsboro, on each of her SNAP Application Forms. As a result, the defendant received an over issuance of \$15,803.00 in SNAP benefits which she was not entitled to receive. The Affiant's belief is based upon 1.) records, 2.) witnesses, and 3.) OIG Investigation 183033.
