DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That the defendant, Timesha Danielle Fleming, in Dorchester County, during the periods of August 1, 2020 to November 30, 2025,
did knowingly and willfully by means of false statement and representation, fraudulently receive Supplemental Nutrition Assistance
Program (SNAP) benefits, based on the submission of twelve (12) SNAP application forms dated, July 6, 2020, February 2, 2021,
July 14, 2021, January 4, 2022, July 13, 2022, January 6, 2023, July 12, 2023, January 16, 2024, June 27, 2024, November 18,
2024, May 12, 2025 and November 21, 2025, on which the defendant intentionally failed to report gross earned income from her
cohabiting husband and her children's father, Robert Fleming III, from his employment with Publix, as required. As a result, the
defendant received an over issuance of \$76,502.00 in SNAP benefits to which she was not entitled. Facts to establish the above
charge against the defendant are based on records and statements of witnesses obtained through SCSOIG investigation
