



## What is SNAP?

SNAP (Supplemental Nutrition Assistance Program), formerly known as Food Stamp benefits, provides eligible low-income households with nutrition assistance by increasing the household's food purchasing power. SNAP helps eligible low-income households purchase food for good health such as: fruits, vegetables, and whole grains. SNAP is a cornerstone of support for struggling South Carolinians to feed their families and has implications for the State's economy as well. SNAP is the largest anti-hunger program in the United States and, therefore, is a vital component of the nutritional safety net for low-income Americans.

## What is SNAP Outreach?

The SNAP Outreach Program provides application assistance and presentations to individuals and community groups who may be eligible to participate in SNAP. Presentations can be individually tailored to meet the requested needs and can cover program requirements and application assistance.

## Application Process:

- The application should be filled out completely to the best of the individual's ability.
- An application is not considered valid unless it contains the applicant's name and address and the signature of a responsible household member or the household's authorized representative.
- The application process may take up to 30 days.
- Applications may be submitted in person, through an authorized representative, by fax or other electronic transmission, by mail, by completing an online electronic application; or by completing a telephonic application.

## Types of SNAP case classifications:

1. ESAP
2. SCCAP
3. Regular SNAP

### **ESAP (Elderly Simplified Application Project)**

To be qualified for SNAP as an ESAP recipient, the follow criteria must be met:

- All household members must be elderly (age 65 or older)
- The household has no earned income.
- No member of the household receives SNAP benefits under SCCAP.
- Complete an interview at initial application and reapplication.

### **SCCAP (South Carolina Combined Application Project)**

To be qualified for SNAP as a SCCAP recipient, the follow criteria must be met:

- Must be receiving SSI in the amount of \$994.00 or \$1,014.00 for SSI and no other income
- The applicant has no earned income.
- The applicant lives alone or purchases and prepares meals separately if living with others.

### **Regular SNAP (Supplemental Nutrition Assistance Program)**

To find out if you are eligible for SNAP, you must submit an application in South Carolina. The following individuals are not eligible to participate in SNAP if one of the criteria below applies:

- Ineligible non-citizens
- Ineligible students
- Individuals disqualified for noncompliance with work requirements.
- Individuals disqualified due to an intentional program violation.
- Individuals who were convicted of a drug related felony based on behavior which occurred after August 22, 1996 (This list is not all inclusive)

### **SNAP Work Provisions**

1. ABAWD
2. Work Registrant

#### **ABAWD (Abled-Bodied Adult Without Dependents)**

- Must be at least 18 years of age but under the age of 65
- Must meet the ABAWD Work Requirement
- Recipient of SNAP benefits are limited to 3 months in a 36-month period if not meeting the ABAWD Work Requirement

#### **Work Registrant**

- **NOT** meeting an exemption from SNAP Work Requirements
- Register for work or be registered by the Agency at the time of application and every 12 months after initial registration.
- Provide the Agency with sufficient information regarding employment status or availability for work.
- Report to an employer to whom referred by the Agency if the potential employment meets the suitability requirements.
- Accept a bona fide offer of suitable employment.
- Do not voluntarily and without good cause quit a job of 30 or more hours a week or reduce work effort to less than 30 hours a week.

### **SNAP to Work Program (formally known as SNAP E&T)**

The SNAP Employment & Training (E&T) Program provides training and employment opportunities to SNAP households to increase their income to reduce their dependency on SNAP benefits and lead to self-sufficiency. The SNAP E&T Program also assist SNAP recipients who are unemployed or underemployed who may need help with improving their skills to obtain gainful employment.

Components offered are:

- Work Readiness Training,
- High school diplomas, General Education Diplomas (GED), and literacy programs
- Vocational Training
- Job retention and job searches
- Workfare (volunteer opportunities) and Work Experience.

Participants can receive certificates & certifications in various areas (Commercial Driver's License [CDL], Certified Nursing Assistant [CNA], General Education Diplomas [GED], phlebotomy, welding, CNC [computer-numeric controlled] Operation, security, etc.) at no cost. E&T Coordinators can also help participants find employment.

SNAP E&T Program individual qualifications include:

- An open and active SNAP case and able to work.
- Must be 16 years of age or older and not attending high school.
- Cannot be receiving Temporary Assistance for Needy Families (TANF) benefits.

**The SNAP E&T Program is a voluntary program therefore, any SNAP only recipient who can work may be eligible to participate in the program ABAWDs and Work Registrants can utilize this program to meet their work requirement.**

Support services will be available if needed for SNAP E&T participants. Support Services include the following:

- Transportation Assistance
- One Time Component Cost (ex. Uniforms, tools, welding glasses, etc.)
- Up to 52 weeks of Child Care
- Rental Assistance
- Technology Support Services (Tablet, MI-FI/Internet, Telephone Connectivity)
- Personnel Protective Equipment (PPE)
- Case Management
- Pathways Scholarship Program
- Entrepreneurship Program

Participation in the SNAP E&T Program also satisfies the Able-Bodied Adult Without Dependents (ABAWD) work requirement.

## DSS Text to Connect Service

The South Carolina Department of Social Services (SCDSS) has partnered with the United Way Association of South Carolina to launch a new texting feature that conveniently connects families and individuals to DSS resources through mobile devices.

To access the services, the mobile device user simply needs to text “DSS” to 211211 and a menu of options will appear. Information on services including foster care, kinship care, adoption, childcare, child support, adult advocacy, SNAP/TANF, and reporting suspected abuse/neglect will appear. Upon making a choice, 211 will respond with a list of resources within seconds, making it easier for individuals and families to find what they are seeking quickly and clearly. This service is also available in Spanish.

### SNAP Changes Effective October 1, 2025

(Income guidelines are updated annually)

USDA has adjusted the income eligibility for the Federal Fiscal Year 2026 which began October 1, 2025. **The gross income limits and the maximum SNAP allotments have been adjusted as follows:**

### Income Guidelines
