DSS is involved in child welfare reform efforts and has committed to systemic improvements for the children and youth in foster care as part of the Final Settlement Agreement related to the Michelle H. lawsuit. DSS requires a web-based information system to ensure the practice improvement reforms are realized. DSS must report various data metrics and information to measure progress, with quarterly reporting to the U.S. District Court Judge overseeing the case. System provides a full feedback loop with a rapid drill-down from agency to individual worker built from live case management

SafeMeasures® through Evident Change is an embedded system, competitively sourced that is critical to providing information and analytics ensuring staff has easy access to up-to-date case information and insights which lead to better outcomes for children and families. Data reporting and analytics also provide critical information measuring DSS's progress meeting the ongoing requirements related to the Michelle H. lawsuit. Transitioning to a different software solution would be cost prohibitive and require extensive time and resources for the procurement, training, and implementation that has already been accomplished. Costs would exceed those of renewing the existing annual maintenance and support with Evident Change. Based on this information the continued utilization of the Evident Change software will ensure continuity, cost efficiency, and uninterrupted support for the critical solution.
