Please explain how these funds will be used to provide a public benefit:

Real Champions, Inc. exists to empower the next generation of children to break the cycle of poverty through our Advocate Mentor program. Poverty is connected to many of the complex societal ills that are impact our world including gun related crimes, early death, poor health outcomes, substance abuse, single family households, incarceration, and more. We will be using the funds we receive to benefit the public of South Carolina by placing an Advocate Mentor with 48 of South Carolina's most vulnerable children in Jasper and Charleston Counties. This Advocate Mentor starts with a child in early elementary school, at the very beginning of their academic career. They then focus on all areas of growth a child needs to succeed including academic and social and emotional growth. Finally, they stay with this child for 12+ years until they finish high school, no matter what. Our goal is to intervene with the child and family early on, empowering the child to break the cycle of generational poverty and helping them to avoid becoming involved in the criminal justice or social services system. We work with the whole family on issues like housing, food insecurity, and job security but our primary focus is on the child and ensuring they have everything they need to stop this cycle for themselves. Research shows that the best way to break this cycle is to start early with a child, so they never step into many of issues that contribute to long-term poverty like early incarceration, teen pregnancy, and substance abuse. Our goal is to eventually provide a mentor to every child who needs one and this money enables us to launch our pilot program in one county and continue it in another to ensure that our methods are based in best practices, research, and measurable outcomes.
