Personally appeared before me the affiant Alexander R Nguyen who being duly sworn deposes and says that defendant Chantel Marie Donis did within this county and state on or about 7/15/2020 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of York) in the following particulars:

DESCRIPTION OF OFFENSE: Food / Food stamps, fraudulent acquisition or use of, value of \$10,000 or more

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That the defendant, Chantel Donis, in York County, during the period of July 15, 2020, through November 31, 2024, did knowingly and willfully, by means of false statements and misrepresentations, fraudulently obtain Supplemental Nutrition Assistance Program (SNAP) benefits. The defendant submitted nine (9) SNAP application forms dated 07/15/2020, 12/23/2020, 7/08/2021, 12/22/2021, 6/30/2022, 12/12/2022, 06/09/2023, 12/12/2023, and 06/06/2024. On these applications, the defendant claimed to be a resident of SC while she was actually living at 711 E. Liberty Street, Salisbury, North Carolina 28144. The defendant also underreported her income and intentionally failed to disclose certain employment on her SNAP applications. As a result, the defendant received an overpayment of \$36,971.00 in SNAP benefits during the claim period, to which she was not entitled. The facts establishing probable cause are based on North Carolina property records and leases, employment documentation, and the
