Jessica S Snider, in Orangeburg County, during the periods of 12/1/2020-3/31/2023 and 7/1/23-11/30/23, did knowingly and willfully by means of false statement and representation fraudulently received Supplemental Nutrition Assistance Program (SNAP) benefits, based on the submission of six (6) annual certification and/or semiannual recertification forms dated 11/5/2020, 5/17/2021, 11/15/2021, 5/20/2022, 11/18/2022 and 7/13/2023, where the defendant willingly and knowingly, failed to report her earned income from Stratosphere Quality on the aforementioned forms during the period. As a result, the defendant received an over issuance of \$25,115.00 in SNAP benefits in which she was not entitled to receive.
